- All contractors must be licensed by the Town of Middletown and State of Delaware. (I.E. pool contractor, electrician, landscaper, fence installer, concrete contractor or any other service required for the pool installation).
- **Please Note:** All communities that have Homeowner Associations, (HOA), or Architectural Committees, may require review and approval of any improvements made on the exterior of your home. Please follow your communities' rules and regulations.
- All in ground, above ground and on ground swimming pools require a permit.
- **Pool Plans:** The Town of Middletown requires three sets of plans / prints for review. These plans provide the detail of construction of the pool.
- **Plot Plan / Mortgage survey:** All above ground and on ground swimming pools requires 3 copies of these plans showing the location where the pool is to be placed on the property. The plans will have to provide set back distances from the rear and side yard. Minimum rear and side yard setback for any part of a pool is 5'. Please see pool location / setbacks for more information.
- **Engineered Lines and Grade compliance plans:** All in ground pools require Lines and Grades plans of all proposed changes to the original grading design at permit application. These plans must include existing home, grading elevations, fence, gates, pool filters, heaters, silt fence location during installation, erosion and sediment detail, and size of the pool. These plans are required to be stamped by a State of Delaware Engineer / Surveyor.
- **Pool location / setbacks:** In ground, above ground and on ground pools are required to show placement of side and rear yards setbacks. The setback requirements are 5'-0" from any rear or side yard property line. There shall be no part of a pool encroachment in the 5'-0" setback, i.e. concrete, decking, filters, heaters, etc.
- **Pool placement and grade as built:** In ground pools require a stamped / sealed as built of the completed pool and grading installation. This is required to be completed by a State of Delaware Engineer / Surveyor. Please submit this prior to scheduling the final inspection, this is to prevent delays in the Certificate of Occupancy. The as built which is required by the Town of Middletown must state this placement is in compliance with the Town of Middletown's Zoning Code and in compliance with engineered grading practices.
- Swimming pools with electric service provided for operation, must be inspected by a third party inspection agency and completed in compliance with the State of Delaware Division of Professional Regulation, Board of Electrical Examiners. Please visit dpr.delaware.gov/boards/electrician/index.shtml for electrical regulations. A final electrical inspection must be completed prior to scheduling a final pool inspection. Please provide a final electrical approved sticker on site at the time of final pool inspection.
- Please **post permits** and have **approved plans** on site at all times prior to beginning of your project. Please have all permits and approved plans on site at the time of required inspections. This is to verify placement and construction of the project.

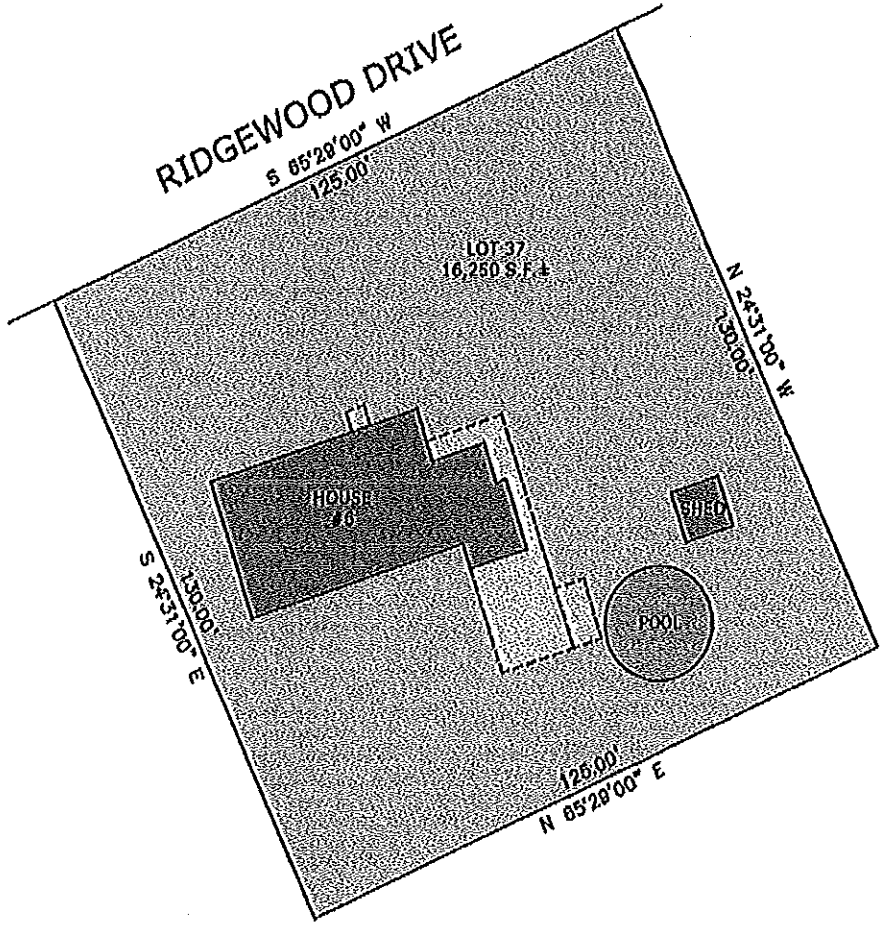
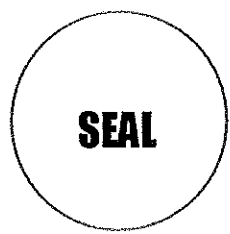
